# TDAP INTRODUCTION

TDAP supports and facilitates businesses through latest information and capacity building initiatives to enhance and improve their leverage in international trade. To achieve its objectives, TDAP organizes as well as participates in local and international trade fairs, country specific exhibitions, trade delegations, conducts seminars and organizes contacts and information exchange events both physically as well on digital platform. This publication is part of the efforts of TDAP to share details and showcase Pakistan's products and services in international markets.



#### PRODUCT PROFILE

Pakistan produced its first vehicle in 1953, at the National Motors Limited, established in Karachi. Pakistan is one of the 36 Automobile Manufacturing Countries in the world. Total strength of Auto-part Manufacturers (APM) is roughly 2800 units in Pakistan. Majority of the sector is in the unorganized sector and 400-500 are in the organized sector. There are more than 10 million four wheeled vehicles on the roads of Pakistan, 25 million two wheelers (motorcycles). The industry was highly regulated until the early 1990s, after deregulation major Japanese manufacturers entered in the market thereby creating some internal competition in this sector. The local auto parts manufacturing industry flourished under the deletion programs but critical components (of engine and transmission assemblies) are still being imported by foreign OEMs.

Between 2014 and 2018, much of which has been fueled by the Automotive Development Policy introduced in 2016.

There are two segments in the auto parts sector: Sales to OEM's for the assembly of new cars, and the aftermarket. The OEM's provide a blue-print that is manufactured to exact specifications required by the local firms. There are several instances of technical collaboration of local parts manufacturers with foreign firms. There is immense potential to invest in spare parts for the automotive industry to serve the growing Production need of locally assembled automobiles.

The country's total investment in the auto sector is above Rs 150 Billion. It provides direct employment to 200,000 people and around 1.2 million indirectly. The aftermarket of Pakistan is estimated to be worth US\$ 3.5 billion.

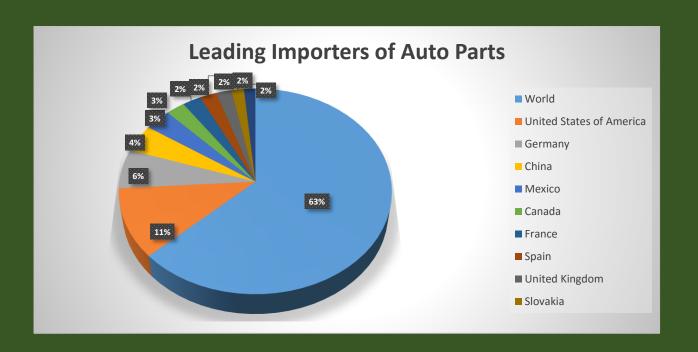
The Auto sector now contributes Rs 92 billion as direct tax in the national exchequer. **HS Codes:** 4011, 4013, 8483, 8507, 8708

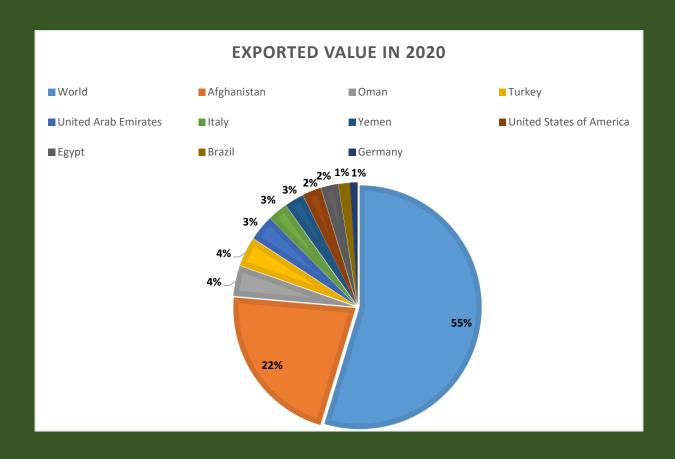

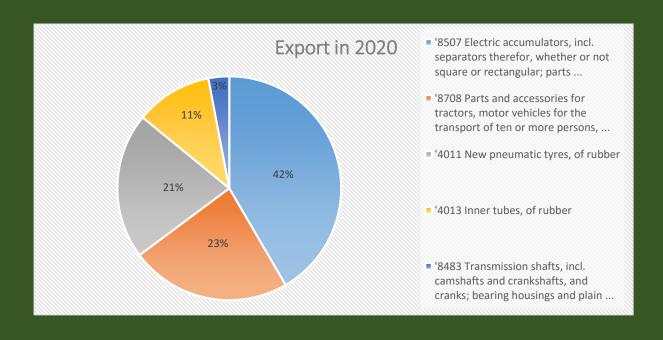
